### Show Site and Food

Site is indoors on stall matting in an area of 5400 sq ft with a ring of 60' X 60'. We ask that you potty the dogs outside the building in the designated area. You will need to bring crates to kennel your dogs. There will be ample crating space.

Food will be **NOT** available at the trial site. There are several fast food restaurants in the nearby vicinity.

**MASKS ARE OPTIONAL WHEN IN THE BUILDING. IF YOU ARE FEELING ILL, EXPOSED OR TESTED POSITIVE TO COVID, PLEASE DO NOT ENTER THE BUILDING.**

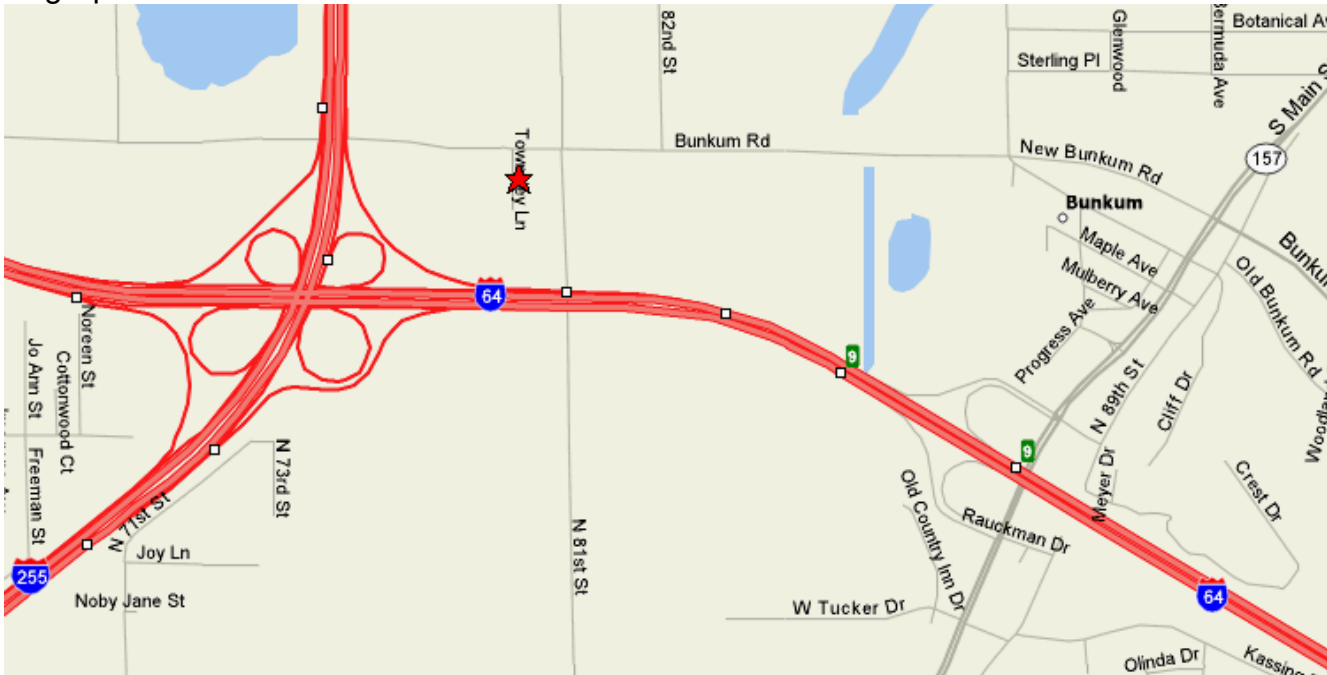

## DIRECTIONS

Take I-64 West (from Eastern Illinois) or I-64 East (from St. Louis) to IL-157 N exit 9 (Caseyville/Centreville). Turn North on IL-157 N and go 0.3 miles. Turn left at New Bunkum Road and go 0.4 miles, continuing on Bunkum Road an additional 0.8 miles. Turn left at Townsley Lane to Dog Sports at Kim's.



## **NOTICE TO EXHIBITORS**

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee. A refund of all but \$5.00 will be given for bitches in season. A letter from your veterinarian is required by the first day of the Trial.
- All fees must be paid in US funds. There will be a Returned Check Fee of \$25.00 for returned checks.
- In the event of withdrawal from the event, checks will NOT be returned. All unused checks will be destroyed.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior, may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- All dogs must be on leash at all times except when using the warm-up area or in the agility ring.
- No entry fee will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbance, fire, an act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee.
- Obstacles shall meet the specifications for obstacles in the current edition of the Regulations for Agility Trials.
- Exhibitors are responsible for complete, accurate and legible information on entry forms;

- illegible or incomplete entries cannot be entered in the Trial.
- Exhibitors must clean up after their dogs at the hotel and at the Trial Site.
- Food and toys are not permitted in the course area and handlers are not allowed to use whistles or other instruments or devices.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. Exhibitors may wear shirts or insignias of their training group, if they wish.
- At the handler's option, the dog may wear a flat (buckle or quick release) collar without tags or other attachments. Choke collars, pinch collars, electric and dummy electric collars are prohibited.
- Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in an excusal from the ring.

**Obstacle Familiarization** - Obstacle familiarization will be held Saturday and Sunday mornings 15 minutes prior to the judges briefing for dogs and handlers who did not previously run in the weekend and for Beginner/Level 1 dogs.

**Warm-ups:** A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors. Only dogs entered in the trial may use warm up area. This should be on lead unless dog is under complete control of the handler.

**Show site** – Site is indoors on stall matting in an area of 5400 sq ft with a ring of 60' X 60'. The contact equipment is rubberized and adheres to TDAA specifications.

**Eligibility** - this trial is open to all dogs 17" and under at the withers that are over the age of 12 months, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect a dog's physical or mental performance.

**Move-Ups** - Move-ups will be accepted for dogs earning a title at a prior show up to the closing date. Move-up requests must be in writing but may be sent via e-mail. Move-ups will also be accepted if a dog completes a title during the running of this Trial. In such case, the Move-Up request must be made immediately upon posting of scores for the class in which the title was earned.

**AWARDS:** Ribbons will be awarded for 1st through 3<sup>rd</sup> place in each jump height of each class. Qualifying ribbons will be awarded to all dogs receiving a Qualifying Score. FEO (For Exhibition Only) will be offered. Title ribbons will also be available. GSLAC will give a special award to any dog having a perfect weekend. The dog must be entered in, and qualify in, all runs during the weekend.

### Obstacles

The following is a list of obstacles to be used: (All TDAA size):

- A-frame (6'8" sides)
- Weave Poles (20" centers)
- Table (36" sides)
- Dog-walk (8' planks / slatted)
- Tire Jump (16")
- Single and Winged Jumps
- Teeter (8' plank)

## Class Information

### Standard Class

- **Beginner Agility** - All dogs shall be eligible for participation in this class
- **Intermediate Agility** - Only dogs who have earned the Teacup Beginner Agile Dog (TBAD) shall be eligible for participation in this class.
- **Superior Agility** - Only dogs who have earned the Teacup Intermediate Agile Dog (TIAD) shall be eligible for participation in this class.

### Games Classes

- **Games I** - All dogs shall be eligible for participation in this class.
- **Games II** - Only dogs who have earned the Games I (TG1) shall be eligible for participation in this class.
- **Games III** - Only dogs who have earned the Games II (TG2) shall be eligible for participation in this class.

### **Full House**

#### **Briefing:**

Full House is a game of timing in which the dog is obligated to collect the elements of the full house, earn as many other points as possible, and end time without losing points on a time penalty. Full House is scored Points, Less Penalty, Then Time ER6

Point accumulation time differs by jump height

2,4,8,12 inch whistle at 35 seconds, total game time, 40 seconds

16inch whistle at 30 seconds, total game time, 35 seconds

#### **Scoring**

Jump 1 pt.

Circles – 2 points

Joker 5 points

The Table stops the clock and is live at all times. 0 points

#### **Qualifying**

Game 1 – 19 points

Game 2 – 22 points

Game 3 – 25 points

### **Black Hole**

#### **Briefing –**

Black Hole is a numbered course requiring the handler to simply avoid any tunnels [Black hole] with the dog. A dog that goes into a Black Hole is subject to a significant penalty. Black Hole is scored Time, Plus Faults ER5

#### **Scoring**

Jump 1 point

Tire or weaves – 3 points

Contact obstacles – 5 points

Faulted obstacles will earn no points. Refusals are not faulted. A wrong course except into a tunnel is

not faulted. Errors in weaving are not faulted. However, the handler must correct the dog's error or earn failure to perform.

The dog earns a bonus of 10 points for doing this course in 50 seconds or less. The bonus is added to the dog's score.

## **Wild West Pinball**

### **Briefing**

Wild West Pinball is a dog's choice point accumulation game. A number of obstacles are set aside on the course with extraordinary value. The handler is obligated to direct his dog to score and pick up as many of those high value obstacles as possible. Wild West Pinball is scored Points, Then Time. ER2

### **Qualifying**

Games 1 – 300 points

Games 2 – 450 points

Games 3 – 600 points

## **Impossible Tunnel**

### **Briefing –**

Impossible tunnel Game is a numbered sequence which features a wicked tangle of tunnels. Obstacles other than tunnels may be used. The impossible Tunnel Game is scored Time, Plus Faults ER5

**Our Judges reserve the right to adapt any game played. Day of show rules supersede all others.**

### **Height Divisions**

Owners are responsible for entering the proper height division. Judges reserve the right to measure dogs entered in any trial. At the handler's option, dogs may be entered in any height division. Dogs that run in a height division higher other than their measured division will be scored in the higher jump height division. Dogs that run in a height division other than their measured division will be scored with dogs of their measured height. TDAA height divisions are:

- 2" jump height: for dogs measuring 4" or less at the withers
- 4" jump height: for dogs measuring 8" or less at the withers
- 8" jump height: for dogs measuring 12" or less at the withers
- 12" jump height: for dogs measuring 16" or less at the withers
- 16" jump height: for dogs measuring 17" or less at the withers

**ALL DOGS WITHOUT A PERMANENT HEIGHT CARD** must be measured prior to the first day of competing at this trial. Arrive early enough to accommodate measuring.

**TWO MEASUREMENTS BY TDAA JUDGES** are needed to show a dog in TDAA.

### **For Exhibition Only (FEO)**

TDAA allows FEO runs open to any TDAA registered dog in any class; offered at the option of the host club. FEO dogs may run on lead. FEO runs do not count toward TDAA titles. No treats or food allowed. FEO will have a maximum of 1.5 times of the SCT. FEO cannot repeat any obstacles. No training in the ring.

### **Disabled Handlers**

A time exemption will be granted to disabled handlers amounting to 4 seconds in Standard course times and in qualifying course times for Games classes. Proof of disability shall be a copy of the handler's disability parking tag or other official documentation, which must be included with the entry or presented at check-in at the trial.

### **Entries**

#### ***Closing Date is November 1, 2023***

Entries will not be accepted without fees. No entries will be accepted which require a signature for delivery. All entries must be submitted on official TDAA Agility Entry forms: one dog per entry form.

#### **Photocopied entries without the signed TDAA agreement attached are NOT acceptable.**

Unsigned, incomplete or illegible entries are NOT acceptable and cannot be entered in the Trial. Faxed entries and/or credit cards cannot be accepted. Returned checks do not constitute a valid entry.

### **VOLUNTEER SIGN UP**

Volunteers are the backbone of any agility trial. By its very nature TDAA is small: small dogs, small equipment, small trials, and small number of handlers. We need all hands to make a small trial work. Please volunteer to work during classes you are not running in. We will make sure you get adequate time to warm up your dog and do your walk-through. We want everyone to have a pleasant experience and at the same time helping to make the trial run smoothly

## **Agreement**

If a registered dog has been acquired by a new owner, it must be entered in the name of the new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
